8. <u>Survey Analysis Summary</u>

- <u>Jeannine Menger:</u> Analyzed the same data as SMC Public Health.
 - Very easy to cross-analyze and get into specific findings
 - Recommend to have numbers we agree upon as baseline so that future numbers can be compared for measurement.

- Envision creating a database on a website (with wizards) where people can pull the data they are looking for.

9. Survey Preliminary Results

- San Mateo County Public Health, Rachel Curtis, PhD
 County Epidemiologist on a team of 11 people. Areas are communicable diseases, TB and STDs. Background is infectious diseases.
 - Rachel led the Youth Survey analysis; Edwina Williams led the Adult Survey analysis
 - they can help us create next survey
 - presented summary of data
- BOS Presentation: 3 items we plan to submit
 - Abstract (the actual mini ppt); Please identify your top remarkable result to Craig and what we are do about it. Craig will chose what to focus on.
 Grant volunteers to work with Craig. The ppt template structure: objective, data, quote, actionable item. Main themes are: To be Seen, To be Safe, To be Belong, To have Access.
 - Packet of full data (full ppt of data)
 - <u>Executive Summary</u> (provides background and methodology)
